

**TERMS & CONDITIONS**

7. The extension will not be in the favour of those who have not taken over charge or have remained absent from duty or have resigned from service.
8. Extension is purely on temporary and contract basis for one year.
9. Their services are liable to termination on one-month prior notice from either side, in case of resignation without notice their one month pay/allowances shall be forfeited to the government treasury.
10. They shall be governed by such rules and regulations may be issued time to time by the Government.


