### TERMS & CONDITIONS

1. The extension will not be in the favor of those who have not taken over charge or have remained absent from duty or have resigned from service.
2. Extension is purely on temporary and contract basis for one year.
3. Their services are liable to termination on one-month prior notice form either side, in case of resignation without notice their one month pay/allowances shall be forfeited to the government treasury.
4. They shall be governed by such rules and regulations may be issued time to time by the Government.
5. Their services shall be terminated at any time, in case their performance is found unsatisfactory during their contract period. In case of misconduct, they shall be proceeded under the rules framed from time to time.
6. Their appointment is made on school based policy. Therefore, they will have to serve at the place of posting and their services is not transferable to any other station.
