TERMS & CONDITIONS.

- No TA/DA is allowed.
- Charge reports should be submitted to all concerned.
- Appointment is purely on Temporary & Ad-hoc basis for a period of one-year w.e.f 01-07-2021 to 30-06-2022.
- They should not be handed over charge if their age exceeds 35 (Thirty-Five) or below 18 years of age.
- The upper age limit in r/o all candidates has already been relaxed by Govt. of Khyber Pakhtunkhwa SOE-III (E&AD) 2-1 / 2007 dated: 01.03.2008 up to three years being backward area.
- Appointment is subject to the condition that their certificates/documents must be verified from the concerned institutions, and anyone found producing bogus certificates or degrees their appointment shall be cancelled and they will be reported to the Law enforcing agencies for further legal action.

7. If any meritorious candidate is deprived of appointment by this order, the appointment order of the lowest candidate in merit shall be withdrawn on acceptance of the appeal and adjustment order will be reviewed accordingly as per merit.
8. Their services are liable to termination of one month's prior notice from either side. In case of resignation without notice their one month pay/allowances shall be forfeited to the Government treasury.
9. Their Pay shall not be drawn until and unless a certificate issued by this office that to the effect that their documents have been verified.
10. District Accounts Officers (DAO) Swat should release their salary on the production of duty certificate duly signed by the Principal / Head mistress / DDO concerned and countersigned by this office.
11. They should join their posts within 15 days after the issuance of appointment order. In case of failure to join the post within 15 days, their appointment shall stand expired automatically and no subsequent appeal etc. shall be entertained.
12. Health & Age Certificate should be produced from the Medical Superintendent before taking over charge.
13. They will be governed by such Rules and Regulations as may be issued from time to time by the Government.
14. Their services shall be terminated at any time in case their performance is found unsatisfactory during their service period. In case of misconduct, they shall be proceeded against under the relevant rules & regulations announced from time to time by the Government.
15. Posting / adjustment is the discretionary powers of the Appointing Authority and no one has the right to claim for adjustment at any specific school.
16. Their appointment is Ad-hoc and school based. They shall have to serve at their place of posting and their services are not transferable to any other station.
17. Before handing over charge to them, their documents may be checked and if found bogus or fake they may be reported to this office for necessary action.
18. Errors and omissions will be acceptable within the specified period.
19. In case of regularization their inter se-seniority shall be determined on the basis of their merit position and the date of taking over charge shall not affect their inter se-seniority
20. They will receive nine months training from RITE/PITE.
21. In case of any discrepancy in documents, oversights or clerical mistake, the competent authority has the right to modify or withdraw appointment order of a candidate according to rules/policy.
